<sup>i</sup> 'Disclosable Pecuniary Interest' is defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012/1464 and includes matters set out in questions A to G inclusive of this schedule.

<sup>ii</sup> "Your partner" means (a) your spouse or civil partner; (b) a person with whom you are living as husband or wife; (c) a person with whom you are living as if you were civil partners.

<sup>iii</sup> "12 months" means the period of 12 months ending with the day on which you give a notification for the purposes of the Localism Act 2011 sections 30(1) (ie, notification of pecuniary interests within 28 days of taking office) or 31(7) (ie, notification of pecuniary interests within 28 days of matter being dealt with) .

<sup>iv</sup> "Body" means a firm in which either of you is a partner or a body corporate of which either of you is a director or a body that either of you has a beneficial interest in the securities of. "Director" includes a member of the committee of management of an industrial and provident society.

<sup>v</sup> "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for either of you (alone or jointly with another) to occupy the land or to receive income.

<sup>vi</sup> "Securities" means shares, debenture stock, loan stock, bond units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

<sup>vii</sup> "Sensitive Interest" means the nature of the interest is such that the councillor and the Monitoring Officer consider that disclosure of the interest could lead to the member to being subject to violence or intimidation.
